**Unfinished Business:**

**2008 Fall Show: Willis Plank**

- There was a low turnout on Friday night to assist with setup.
- We set up the following: 22 full set-ups, with 2 cavies, and a registrar.
- Entries: Approximately 1080 and 1030 Open rabbit, and 104 Open cavy entries. Youth had 776 in one show, with about 125 less in the other show. 50 + youth cavies.
- Judges: One was a no show, one judge did not get out of bed on time, one judge was ill. At the show, a Michigan judge was asked if they could judge, and they did not accept the offer to judge.
- Judges: Hired 21 Rabbit judges + 2 Cavy judges = 23 judges  
Used 19 Rabbit judges with Mark Stewardson for \$100.00 and Willis Plank for \$50.00  
George Raiser judged 100 head and left ill. So we saved on judges fees.

## 2009 Convention Specialty Shows:

Helena Hickerson from MCBA said that there is a strong push to encourage cavy members to attend the MSRBA banquet for their awards. John Soper is scheduling something for cavies at the judges conference. There will be a single Specialty cavy show on Sunday, and one on Saturday at the regular show.

**Any Other New Business:**

George Carpenter made a motion that MSRBA release Great Lakes Rabbit & Cavy Shows from their contract with MSRBA of the initial investment amount plus the accrued interest. Jane Burt turned the meeting over to Vice President, Willis Plank. Discussion. Second by Henry Carpenter. Motion passed unanimously by all voting members.

**Standing Rule: Convention awards for every sanctioned breed.** Discussion on sanctioning breeds. Fifteen head must be shown in open and youth combined for the breed to be sanctioned.

**Equipment:**

Discussion by Tony Parker on carpeting for the show tables. No Berber. Discussion on the carpets verses floor mats for the show setups like SCMRBA has. Janet Bowers made the motion, second by Donna Mallory to purchase enough mats for all of the show setups. Motion carried.

Motion to adjourn by Larry Walthorn, second by Ronda Hemenway. Motion carried.
